Terms of References

1. Background:

A Circular Economy (CE) differs fundamentally from a linear Economy in how resources are utilized and managed. The conventional "take-make-dispose" approach, which is used in linear economies, depletes natural resources, produces waste, and worsens the environment. On the other hand, the Circular Economy uses a closed-loop system that aims to reduce waste production and resource exploitation. To prolong every products' lives and lessen their impact on the environment, Circular Economy places a strong emphasis on recycling, repairing, reusing, and renovating materials. Circular Economy regards goods as valuable assets rather than throwaway ones, promoting design and production innovation to keep materials in use- as much as possible. The Circular Economy differs from the linear model's unsustainable behaviors in that it emphasizes resource efficiency and waste reduction, which encourages sustainability, lessens reliance on finite resources, and builds resilience against environmental issues.

Thus, the core values of a Circular Economy are: 1. Designing Out Waste and Pollution – preventing waste at the source through eco-design and Circular processes; 2. Keeping Products and Materials in Use – extending product lifecycles through reuse, repair, and remanufacturing; and 3. Regeneration of Natural Systems – restoring ecosystems by returning biological materials safely to nature. Additionally, the Circular Economy framework is underpinned by a transition to renewable energy and materials, which are essential for building a truly sustainable system.

Circular Economy's core principles closely align with the Sustainable Development Goals and focus on reducing waste, reusing materials, and regenerating natural systems, especially SDG 12, which promotes responsible consumption and production patterns to minimize environmental impact.

Further, moving towards low-carbon and sustainable economic practices are key components of Nepal's third Nationally Determined Contribution (NDC 3.0) and the Paris Agreement. It outlines methods for incorporating the ideas of the Circular Economy into the fields of waste management, agriculture, and energy. To lower emissions and pollution, Nepal aims to increase resource efficiency, encourage recycling, and put waste-to-energy projects into action. Additionally, the NDC 3.0 also establishes goals to improve solid waste management, such as encouraging recycling and composting and separating 50% of household garbage at the source by 2030. By

lessening reliance on virgin resources and preventing environmental deterioration, these programs promote a Circular Economy and are in line with SDG 12.

By integrating Circular Economy principles into the formulation of the sectoral as well as intersectoral policies and strategies at the provincial level, Roots of Circularity (ROC) project aims to contribute to Nepal's commitment towards global efforts to address climate change and fosters sustainable growth, ensuring a balance between environmental, economic, and social objectives. Similarly, the project plans to support different stakeholders and ministries for efficient resource management, environmental conservation, national heritage protection, and mitigation of negative impacts. It focuses on low carbon technology, transportation, infrastructure, tourism, and cultural preservation, integrating environmental concerns with development plans.

2. Description, Objectives, Expected Outcomes:

Roots of Circularity (ROC)- Introducing and Integrating Circular Economy in Nepal, funded by the EU Union is a four-year project to be implemented in two target provinces: Bagmati and Lumbini. The project implementation is led by the Impact Hub Association (IHA) through a joint venture of Impact Hub Kathmandu (IHK) and Wildlife Conservation Nepal (WCN). ROC aims to promote a systematic shift of Nepal's linear Economy models towards Circular Economy.

ROC project is aimed at raising awareness among the relevant stakeholders and contributing towards policy development through multiple dialogue/exchange session among CSOs, private sectors, academic institution and policy makers across different levels to enhance capacity building and consolidating the robust understanding of the Circular Economy principles, exchanging experiences for common approach to Circularity in Nepal. This project will also focus on engaging members of vulnerable and marginalized communities—such as Dalits, indigenous peoples, persons with disabilities, LGBTQIA+ individuals, women, and youth—to identify and explore opportunities for advancing the Circular Economy. It aims to encourage and support their entrepreneurial activities in circular practices, in collaboration with civil society. Provincial-level policy development is also a part of the ROC project, which requires high-level exchange sessions to learn more about the status of the Circularity in the targeted provinces.

This diagnostic study aims to generate evidence-based recommendations to support the transition to a Circular Economy (CE) in Lumbini Province, with a strong emphasis on the priority sectors outlined in Nepal's Third Nationally Determined Contributions (NDC 3.0). The selected organization will assess sectoral readiness, analyze policy and regulatory gaps, and identify strategic entry points for CE practices aligned with NDC 3.0 targets. By engaging key stakeholders, the study will develop a practical roadmap for provincial implementation, with findings to be presented to policymakers to guide sustainable climate action.

The expected three outcomes of this report are-

- **Outcome 1: Informed Sectoral Investment and Policy Focus**
Provincial and national policymakers are equipped with clear, evidence-based insights from a Sectoral Readiness Report, enabling them to prioritize investments and Circular Economy interventions in the most viable sectors. This ensures efficient resource use and stronger alignment with NDC 3.0 targets.
- **Outcome 2: Strengthened Policy and Regulatory Coherence**
A comprehensive Policy and Regulatory Analysis Report will enhance coherence and legal alignment at the provincial level, enabling the development or revision of policies that directly support the Circular Economy transition and are aligned with national climate commitments (e.g., NDC 3.0, Net Zero Strategy, NAP, REDD+).
- **Outcome 3: Accelerated Circular Economy Transition Pathways**
Stakeholders will receive evidence-based, sector-specific Policy Briefs that serve as practical roadmaps for implementing Circular Economy practices in viable priority sectors. This will foster private sector participation, enable targeted actions, and help unlock green financing opportunities aligned with Lumbini Province's readiness and NDC 3.0 goals.

3. Scope of Work

The study will prioritize key sectors identified in Nepal's Nationally Determined Contributions (NDC 3.0) and contribute to both national and international sustainability goals. It will engage stakeholders across government, industry, civil society, and academia to ensure context-specific and locally grounded insights. Through a comprehensive diagnostic of sectoral readiness, policy gaps, regulatory frameworks, and financing opportunities, the study will generate evidence-based recommendations to support the transition to a Circular Economy in Lumbini Province.

The findings must be translated into a roadmap and policy guidance tailored to provincial-level implementation. The findings of the study must be prepared for presentation to policymakers in the relevant ministries of Lumbini Province, emphasizing the development of essential guidelines to facilitate the transition to Circularity frameworks or, at the very least, a relevant policy guideline for a specific sector.

4. Key Deliverables:

The findings from this study will serve as a foundation for evidence-based policymaking, ensuring Lumbini Province's sustainable transition to a Circular Economy while contributing to Nepal's broader climate and economic resilience goals.

6. Eligibility

a. This Request for Proposal (RFP) outlines the requirements for an open and competitive bidding process. All eligible registered firms with relevant mandates and experience are invited to apply.

b. Joint ventures and associations are allowed, but subcontracting is not. Applicants or the associated members in the case of joint ventures, or associations, must have prior experience in policy research in similar sectors. Proposals from applicants without prior relevant experience will not be considered for selection. The contract however will be signed with the lead organisation.

The team's qualification is also one of the pre-qualification criteria; evaluation will verify submitted documents in the required format. Any document lacking valid proof will be deemed ineligible. WCN reserves the right to accept or reject credential proof at its discretion without providing explanations. Only bidders meeting the eligibility criteria through properly submitted documents will proceed to further evaluation stages.

The proposal should give Wildlife Conservation Nepal (WCN) all the information that is needed to assess your bid, detailed information is provided as summarized below:

- i. Organization's details: Including relevant information about the service provider and contact details (as per the provided format-please check Appendix 1).
- ii. Technical Proposal: The approach should present a clear strategy for achieving outcomes efficiently, ensuring structured implementation with built-in flexibility for adaptive management. The technical proposal must align with the stated objectives, scope, and deliverables, and should outline the proposed methodologies in detail, key stages, milestones, and review periods within the specified timeframe. While the format of the technical proposal can be flexible, it

- must not exceed 15 pages. All text should be in Arial font, size 11 with single line spacing (see Proposal Evaluation Criteria for more detail).
- iii. Financial Proposal: The financial proposal must be presented in NPR-denominated financial bids under dedicated headings as per the key deliverables. The proposal must demonstrate both financial feasibility—ensuring that the budget is realistic, sufficient, and aligned with the scope of work—and cost-effectiveness, reflecting efficient use of resources and value for money across all budget lines. It should be a reasonable lump sum, covering all expenses and taxes, exhibiting reasonableness in all allocations (see Proposal Evaluation Criteria for more detail).
 - iv. Area of Experience (about Organization): An overview of expertise and experience on policy research and analysis in different socio-economic sectors including references to previous work carried out in Nepal (as per the provided format-please see Appendix 2).
 - v. Declaration of not being blacklisted and Conflict of Interest (COI): Official declaration (in official letter head in case of organization) that submitting parties have not been blacklisted, debarred, or suspended by any government agency, financial institution, regulatory authority, or any other entity at the national or international level. 8. Proposal Evaluation Criteria

The proposal evaluation aims to assess bids and select the most suitable policy landscaping consultant at a competitive price. WCN will conduct the evaluation, and its decision will be final.

The competitive bids shall be evaluated in the following stages:

- a. Technical proposal
- b. Financial proposal

A. Technical Proposal Evaluation:

- The technical section must include background and context of the study with highlighted objectives that study aims to achieve.
- This section must highlight all detailed approaches and methodologies to be carried out during the scoping study and policy research.
- The proposal must list all the key deliverables and provide the anticipated impact of the study.
- Qualification of the key personnel to be involved in this assignment (with CVs of team members in the prescribed format attached to this section).

The technical proposals will be evaluated on the quality, coherence, and relevance with key deliverables: Sectoral Readiness Assessment Report, Policy and Regulatory Analysis Report, and Strategic Framework and Roadmap Report. A well-structured research framework/methodology will be essential, as it underpins the overall objectivity, clarity, and reliability of the study. Proposals will be evaluated on the consultant's ability to design and apply a robust research framework, implement effective data collection and analytical methods, and facilitate meaningful stakeholder engagement. Priority will be given to proposals that demonstrate a clear understanding of Nepal's policies (NDC, Net Zero Strategy, NAP, REDD+ and such) and translate findings into actionable, policy-relevant recommendations relevant to Circular Economy. The selection process will heavily weigh on the consultant's ability to generate context-sensitive, evidence-based outputs that directly influence sectoral transition planning, regulatory alignment, and investment objectives.

B. Financial Evaluation and Scoring Method

The financial evaluation will be based on the NPR-denominated financial bids submitted by each applicant. The bid should be a lump sum, covering all expenses and taxes. Financial proposals will be assessed based on legitimacy/reasonableness of the allocations to different activities as proposed by the applicant. The financial proposal carries a total score of 20 points.

9. Overall Evaluation:

Bids will be assessed using the Combined Quality-Cost Based System (QCBS), with technical proposals carrying a weight of 80 points and financial proposals 20 points. The total score will be calculated as:

$$\text{Total Score} = \text{Technical Proposal Score} + \text{Financial Proposal Score}$$

The applicant with the highest combined score will be recommended for the contract.

10. Tentative Budget:

The proposal must carry financial bids up to NPR 1,450,000 (one million and four hundred fifty thousand only) including all applicable taxes.

11. Contract and Payment Terms:

Upon completion of the evaluation, shortlisted applicants will be contacted, and a presentation may be required and subsequent procedural steps will follow.

A formal contract will then be executed, following which the award will be officially granted.
